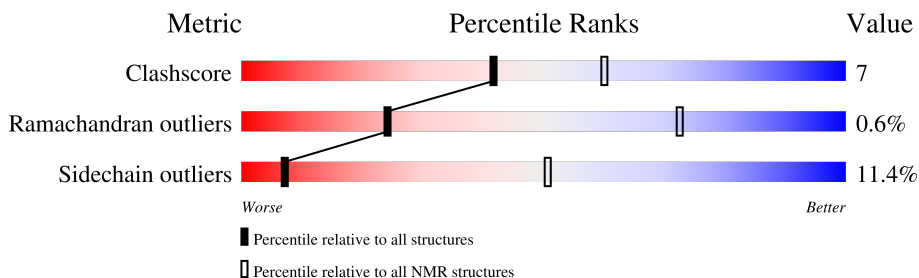
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*SOLUTION NMR*

The overall completeness of chemical shifts assignment is 53%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$

## 2 Ensemble composition and analysis i

This entry contains 20 models. Model 2 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *lowest energy*.

The following residues are included in the computation of the global validation metrics.

### 3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 2230 atoms, of which 1092 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Major prion protein.

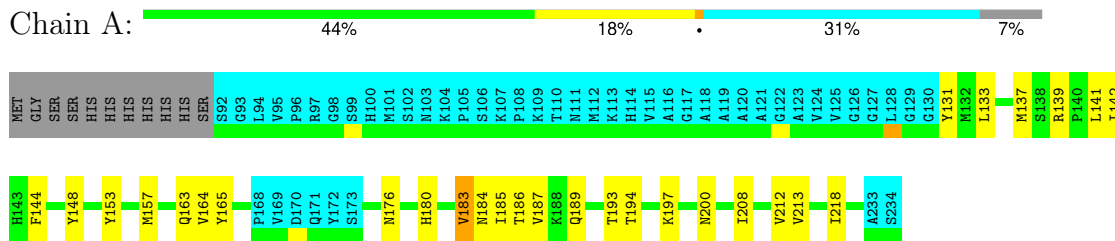

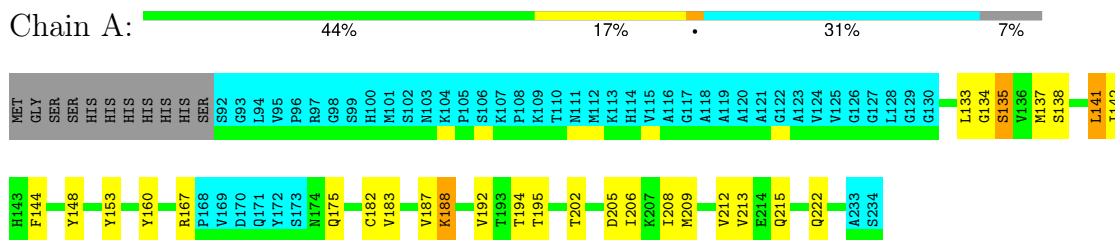






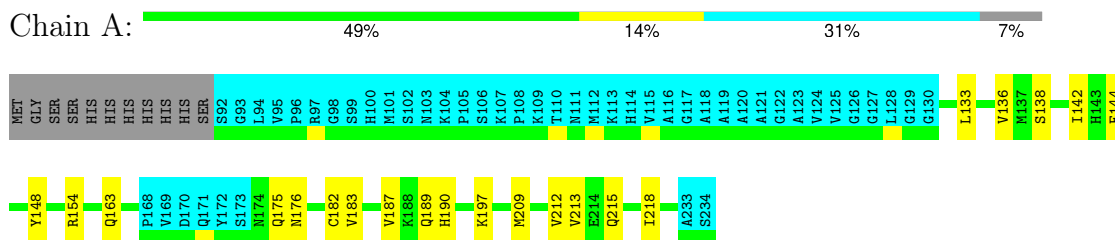

- Molecule 1: Major prion protein



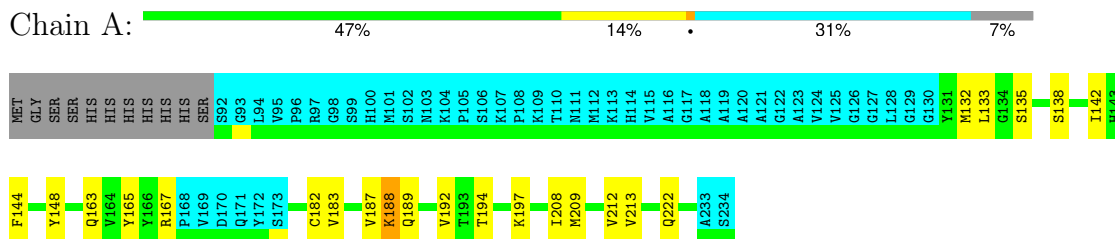
#### 4.2.8 Score per residue for model 8

- Molecule 1: Major prion protein



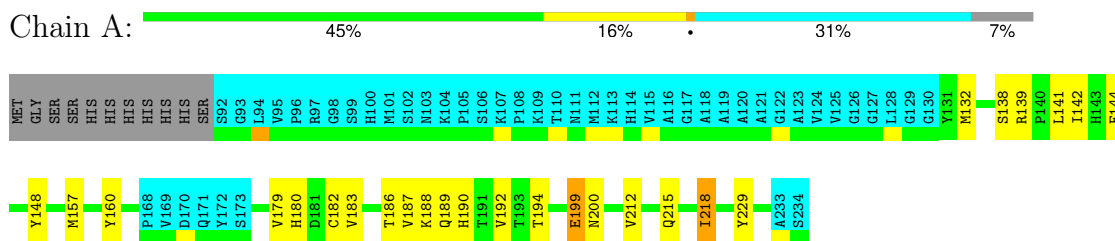

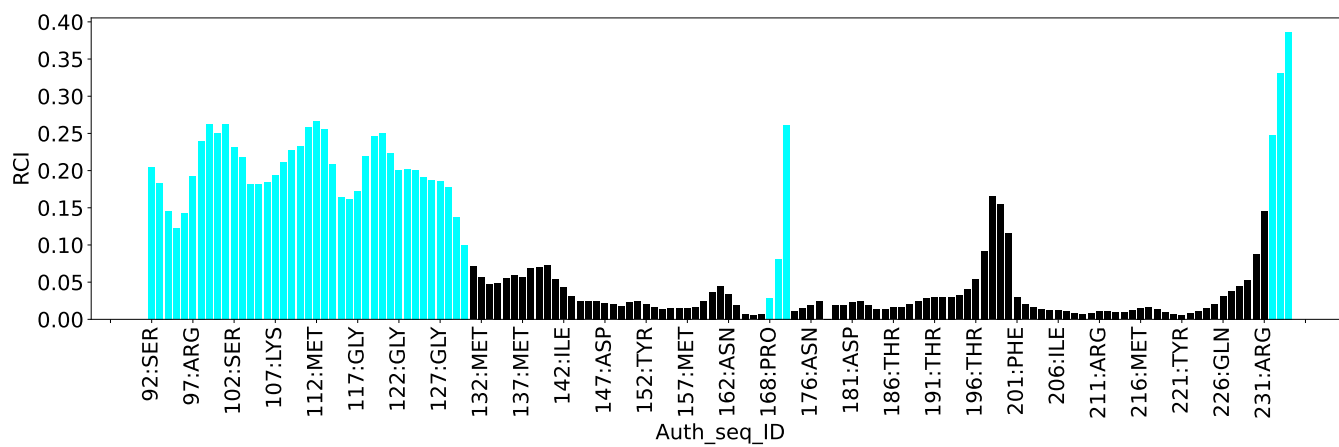

#### 7.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition. If well-defined core and ill-defined regions are not identified then it is shown as gray bars.

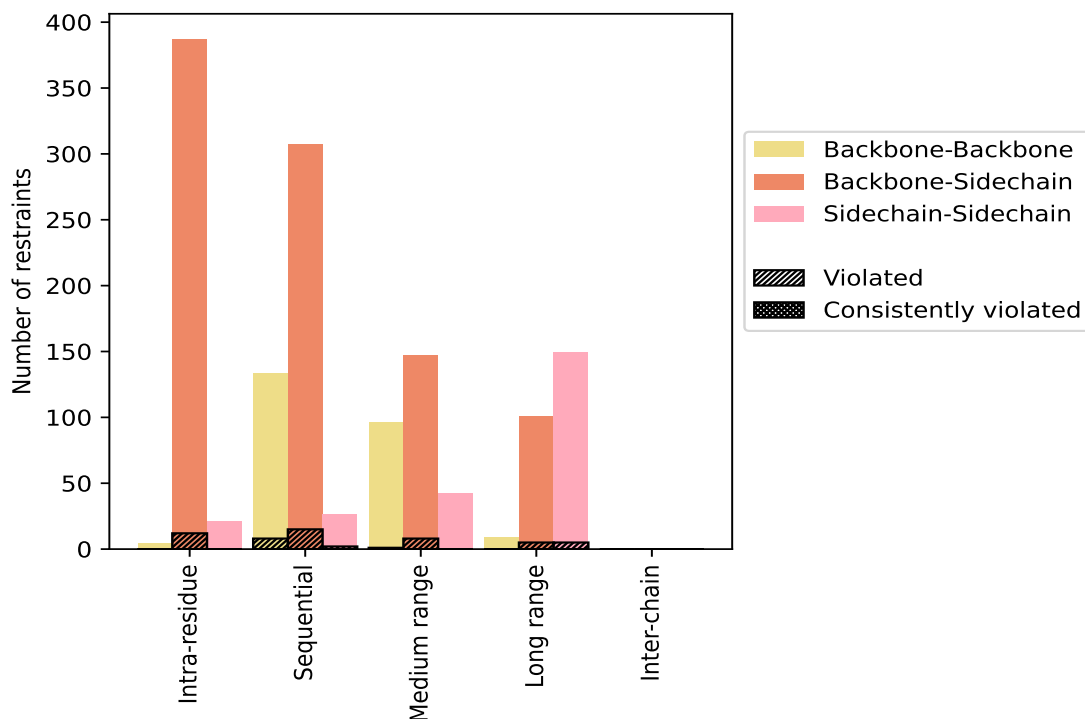

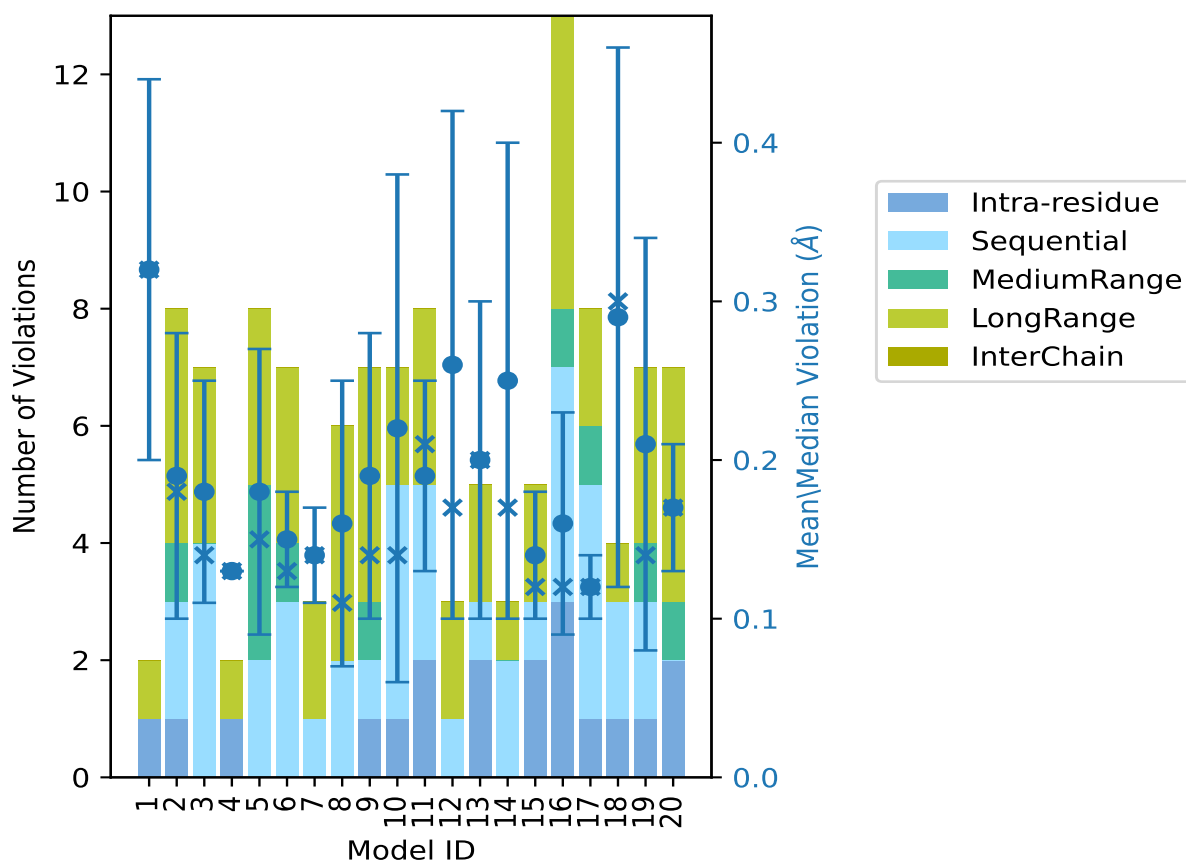

The mean(dot),median(x) and the standard deviation are shown in blue with respect to the y axis on the right

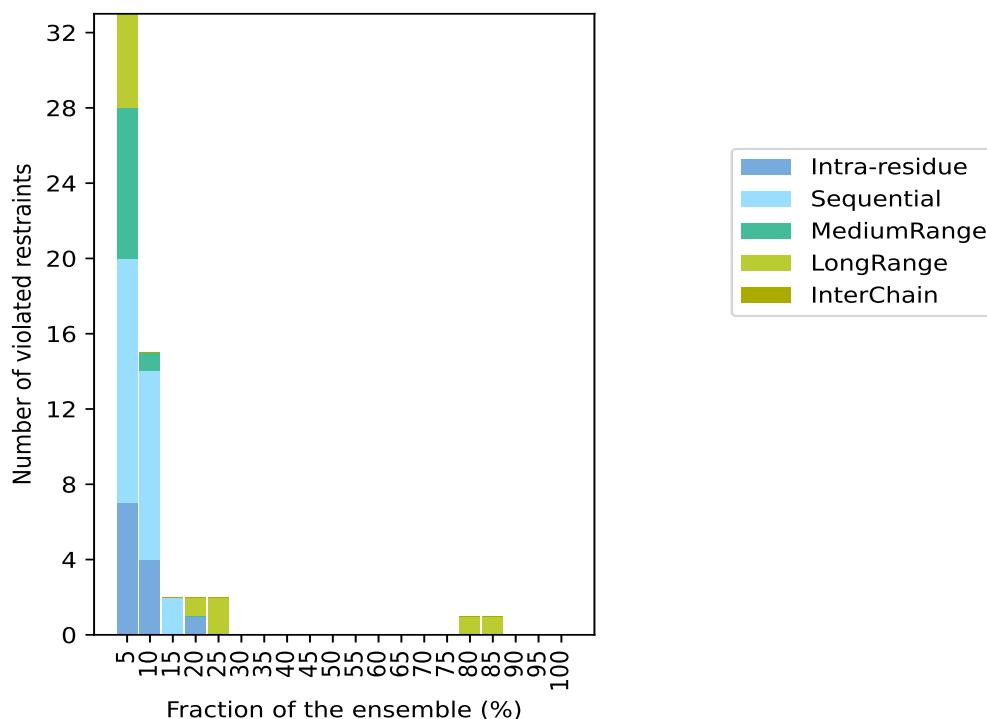

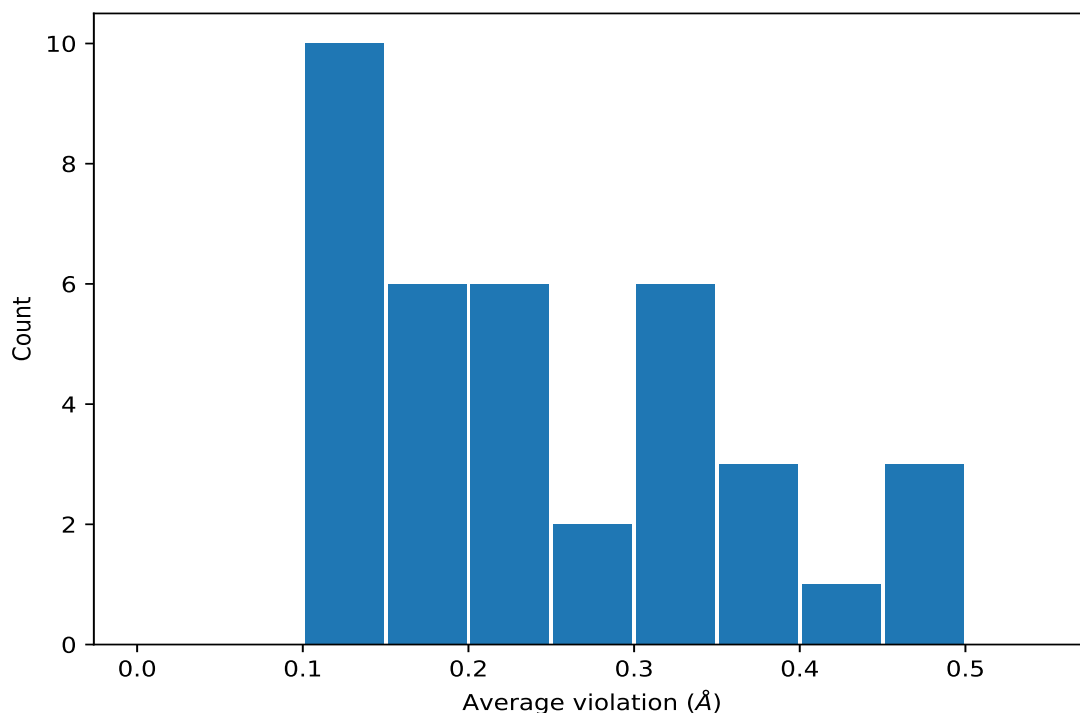

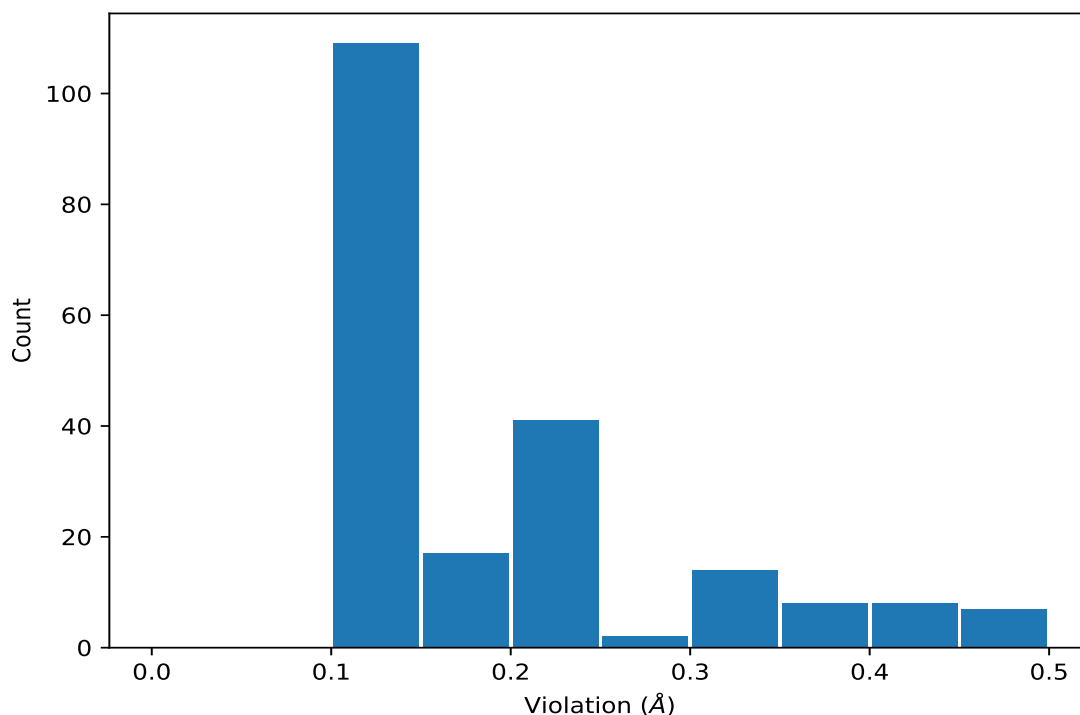

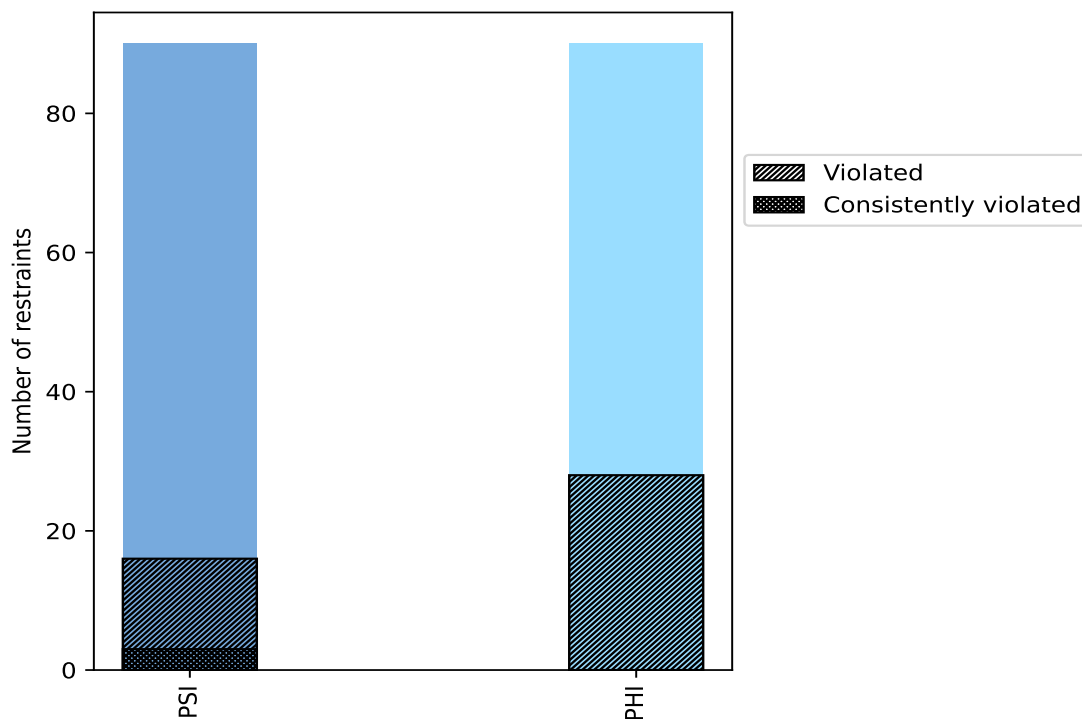

#### 10.1.1 Bar chart : Distribution of dihedral-angles and violations [i](#)



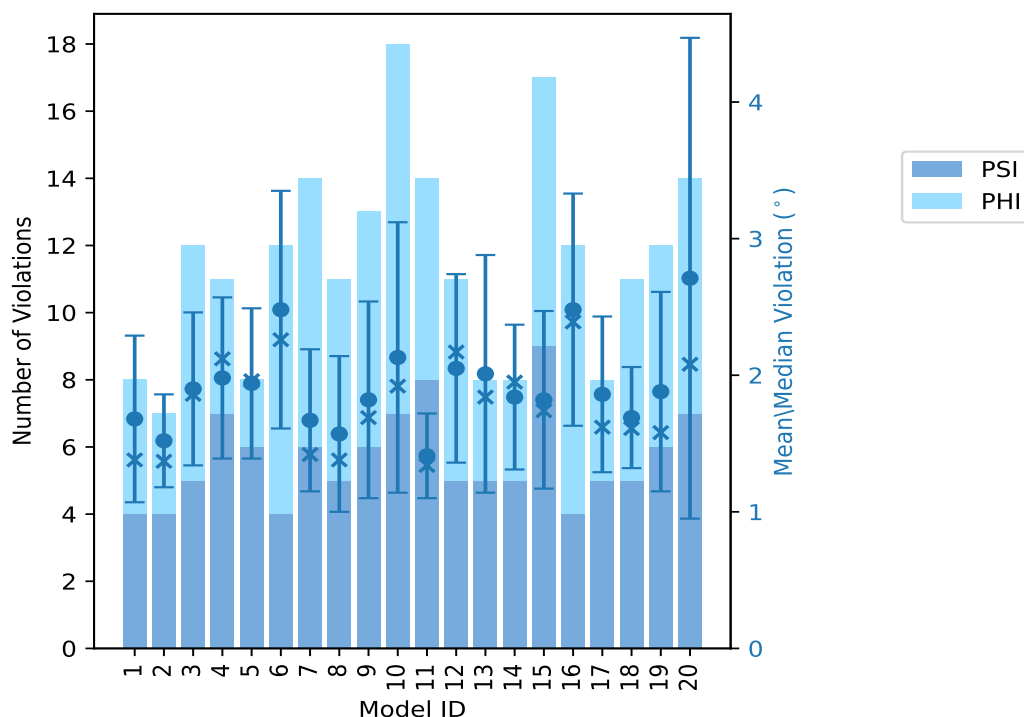

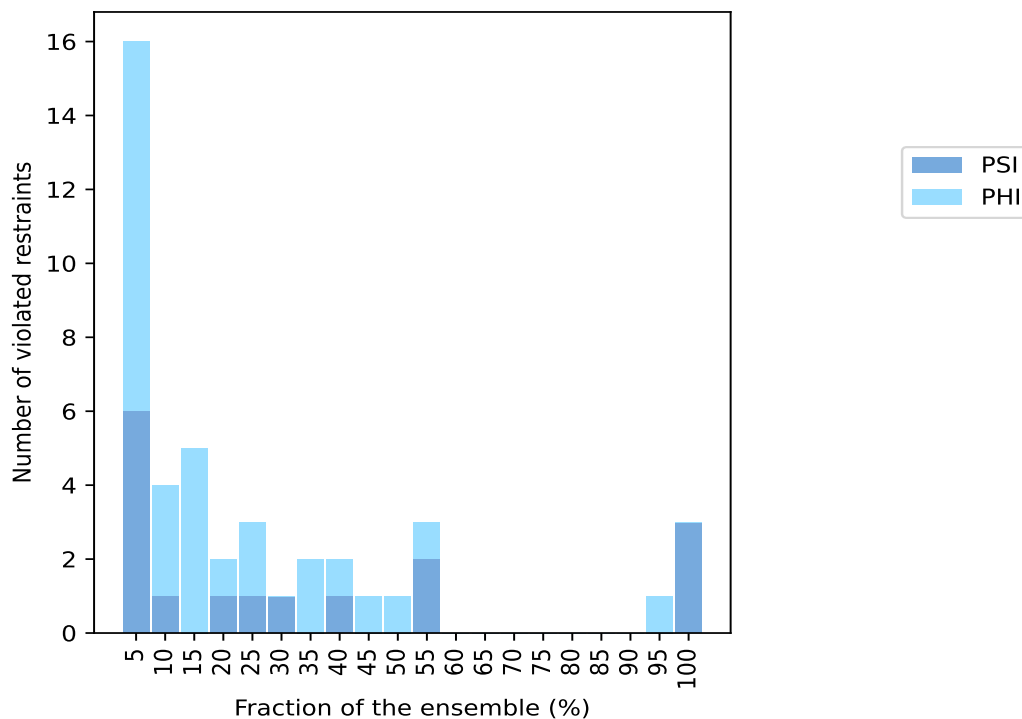

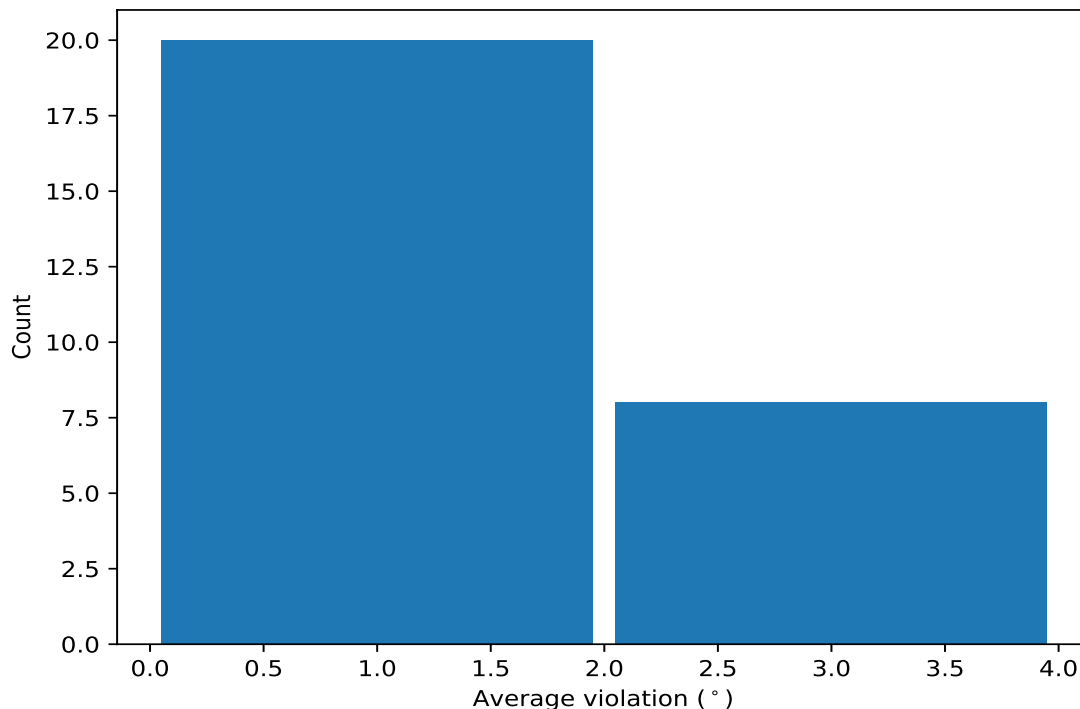

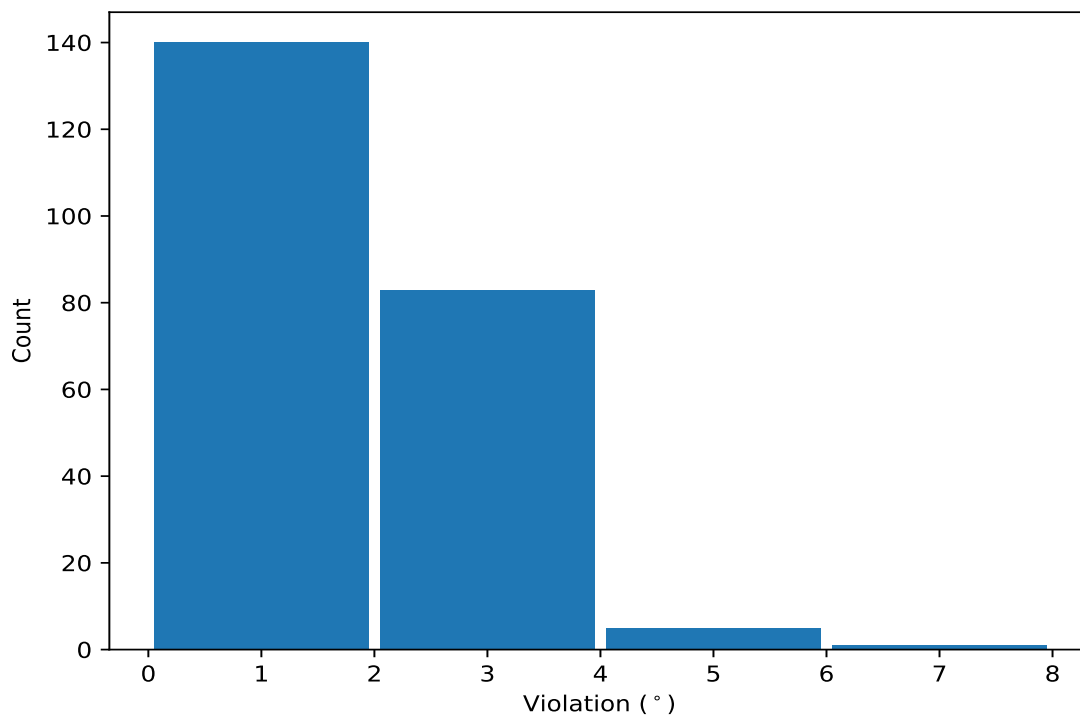
