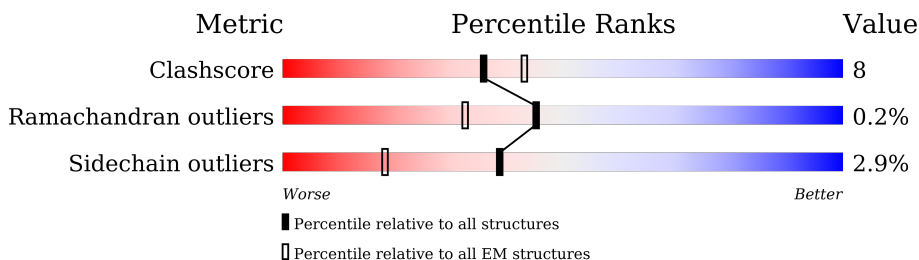
1 Overall quality at a glance

ELECTRON MICROSCOPY

The reported resolution of this entry is 3.26 Å.

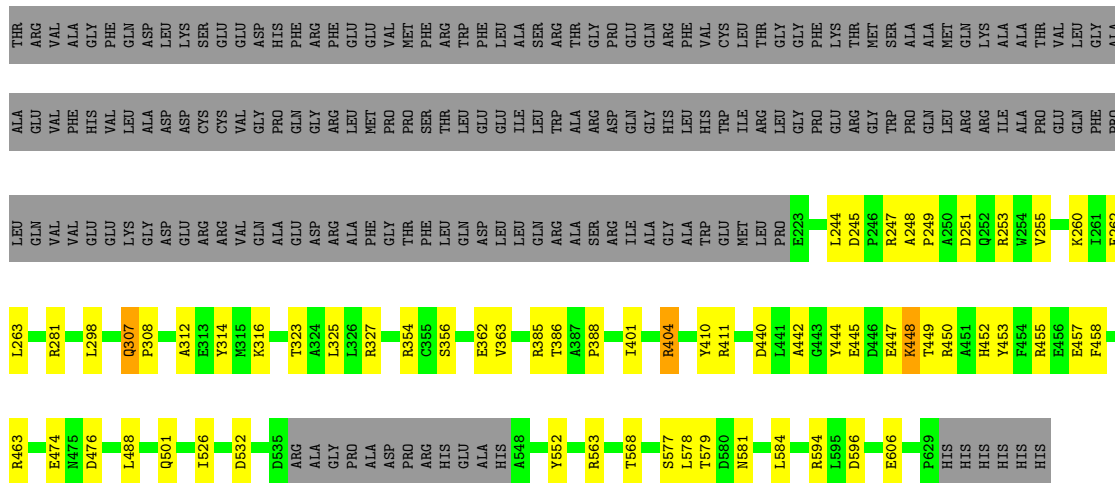

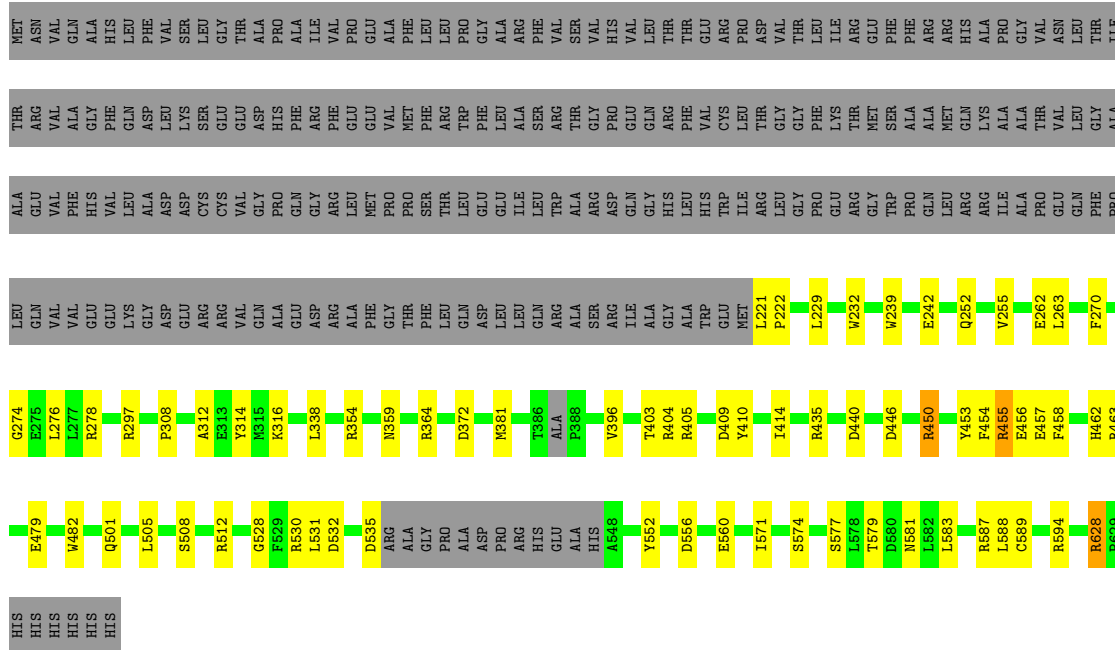

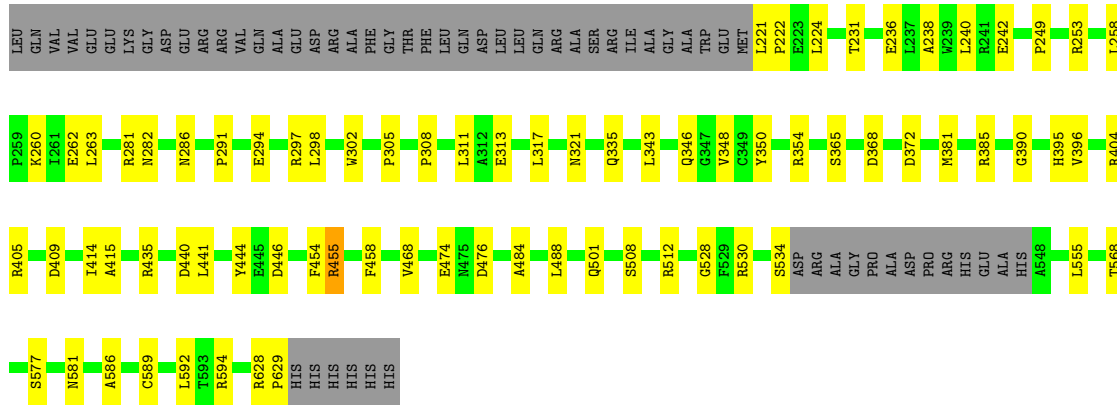


• Molecule 1: Adenosine deaminase domain-containing protein

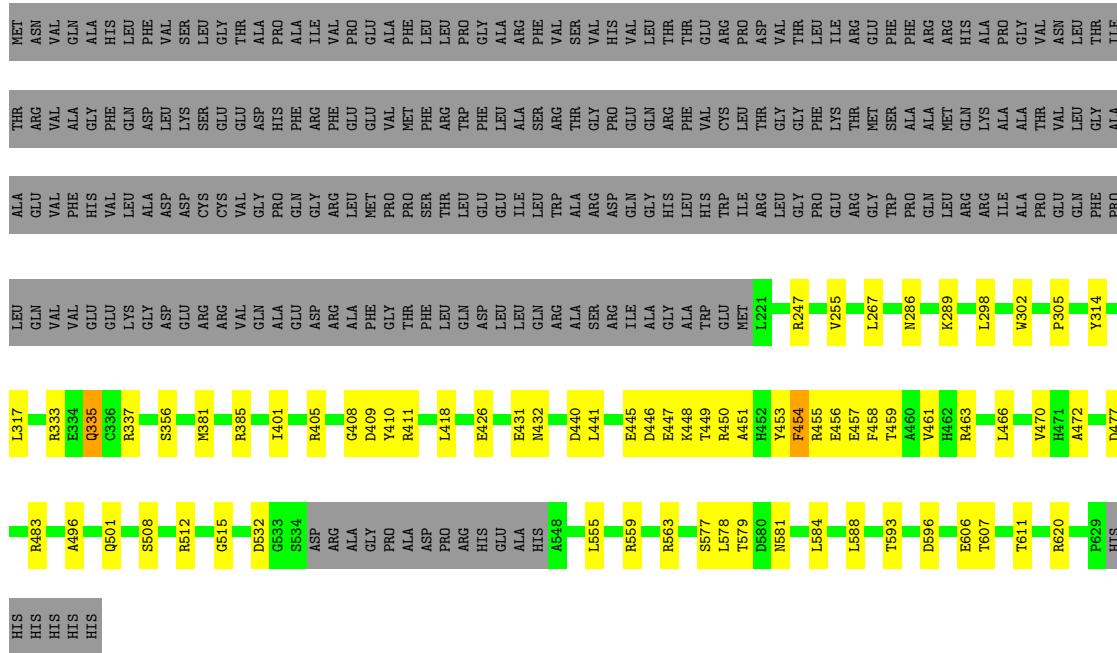
