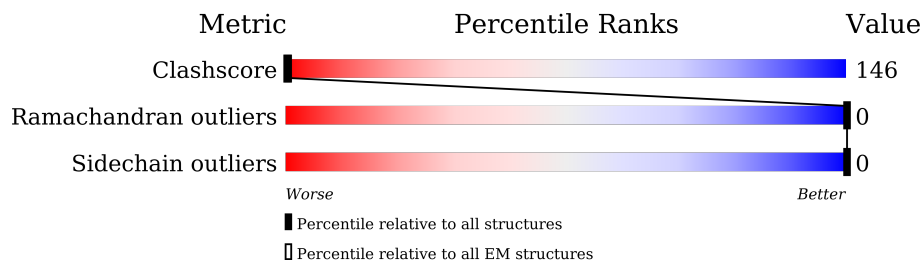
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 4.56 Å.

2 Entry composition

There is only 1 type of molecule in this entry. The entry contains 507 atoms, of which 0 are hydrogens and 0 are deuteriums.

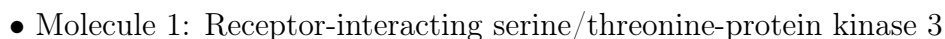
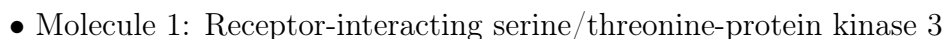

5 Model quality

5.1 Standard geometry

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

5.2 Too-close contacts

The Clashes column lists the number of clashes within the asymmetric unit, whereas Symm-Clashes lists symmetry-related clashes.
