

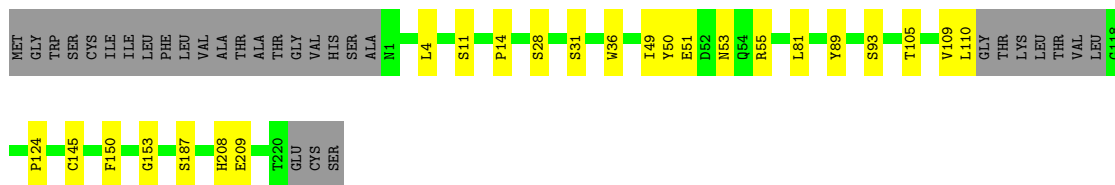
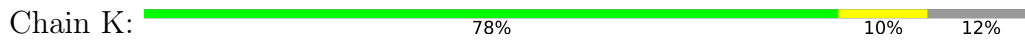




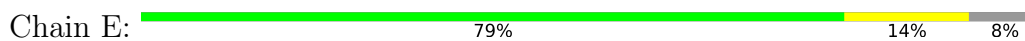
• Molecule 2: Light chain of H18 Fab



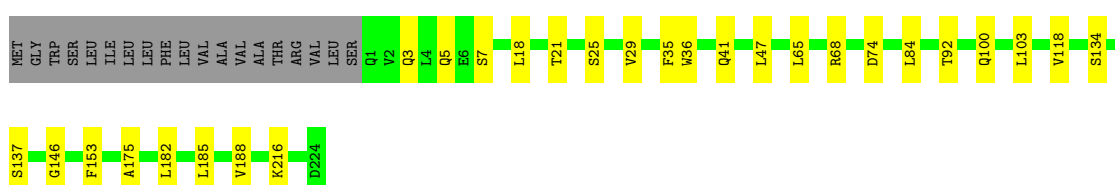
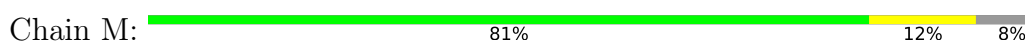
