A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$ . The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion  $< 40\%$ ). The numeric value is given above the bar.

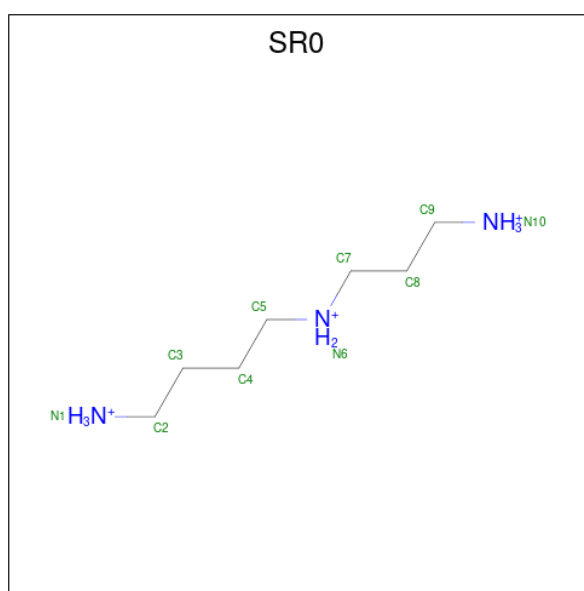

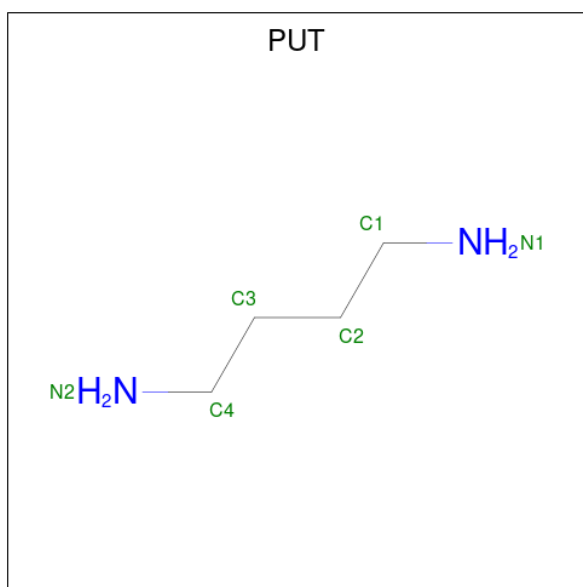

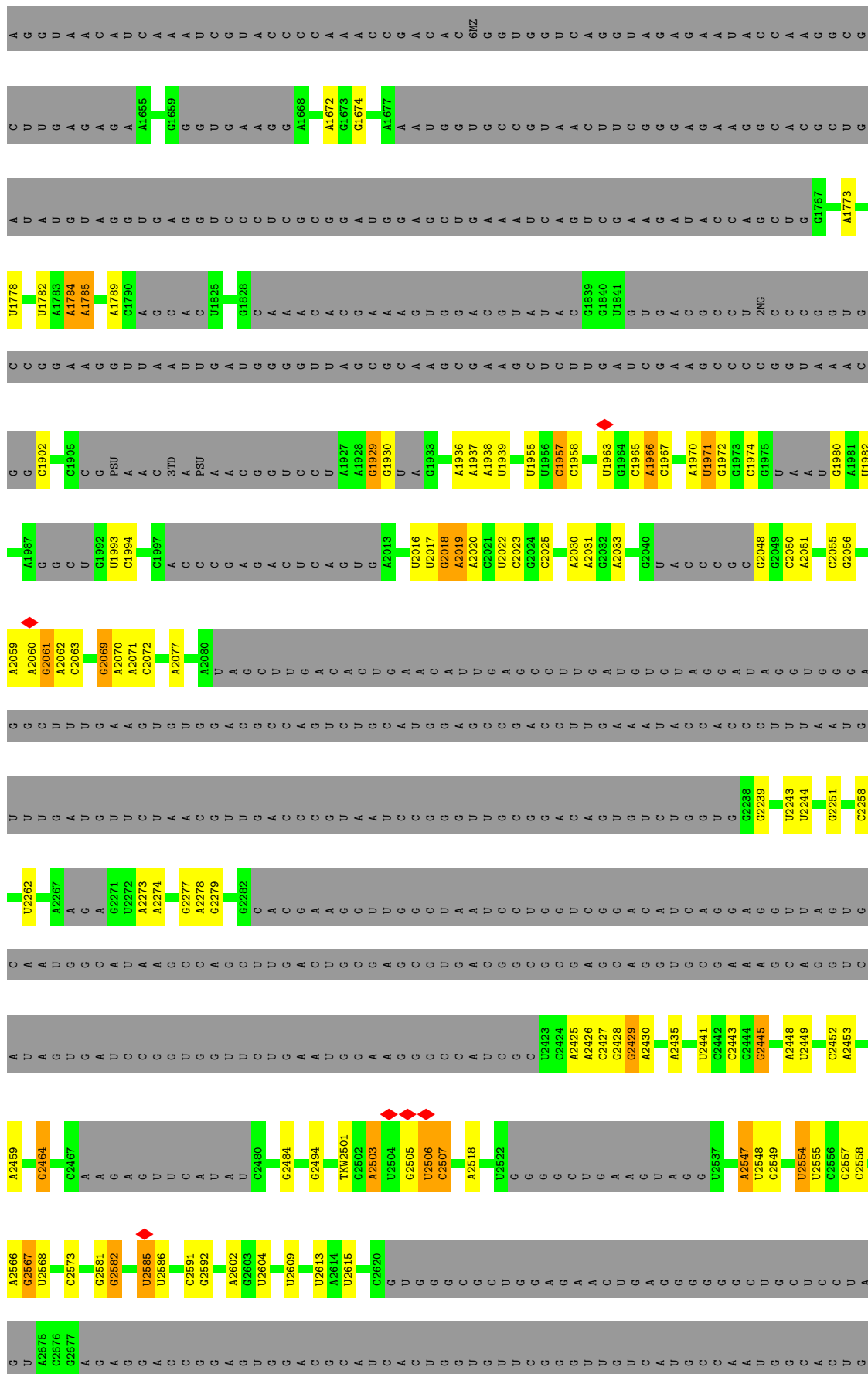

## 5 Model quality i

### 5.1 Standard geometry i

Bond lengths and bond angles in the following residue types are not validated in this section: MS6, K, TKW, OMG, SR0, OMC, 2MG, 2MA, MEQ, 6MZ, PSU, MG, PUT, 4D4, 5MC, 5MU, 1MG, G7M, H2U

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

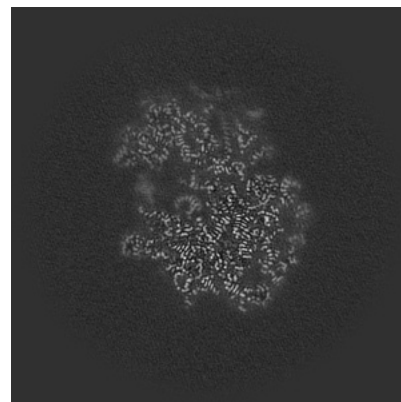

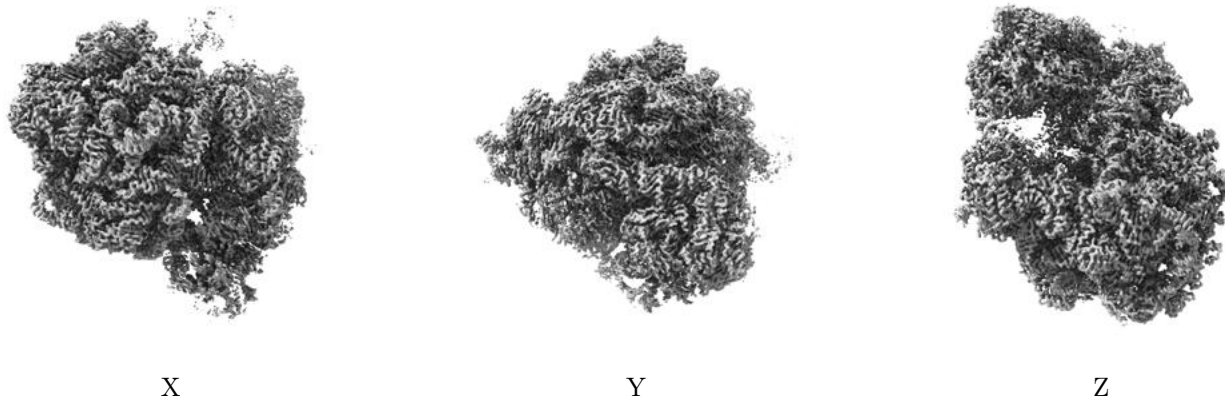

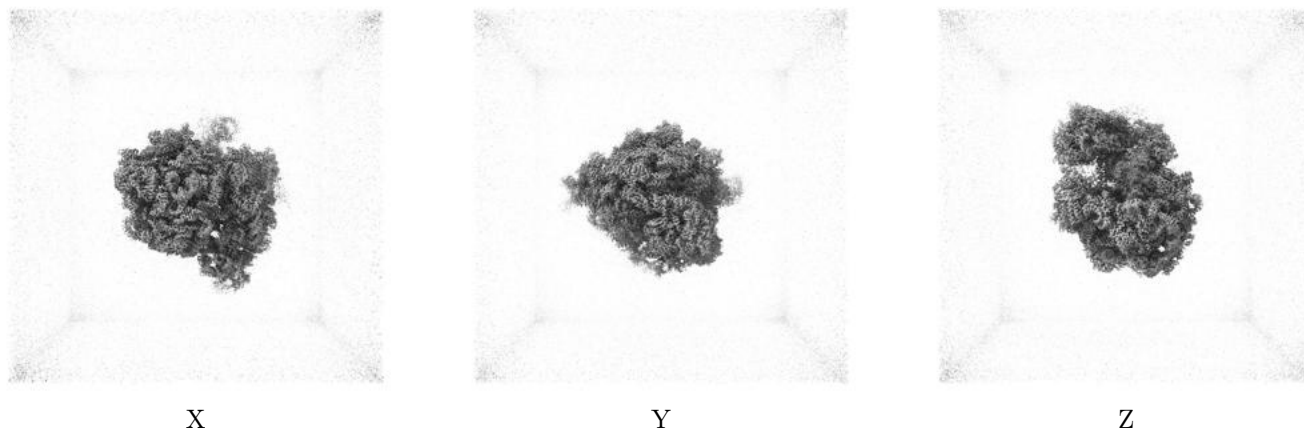

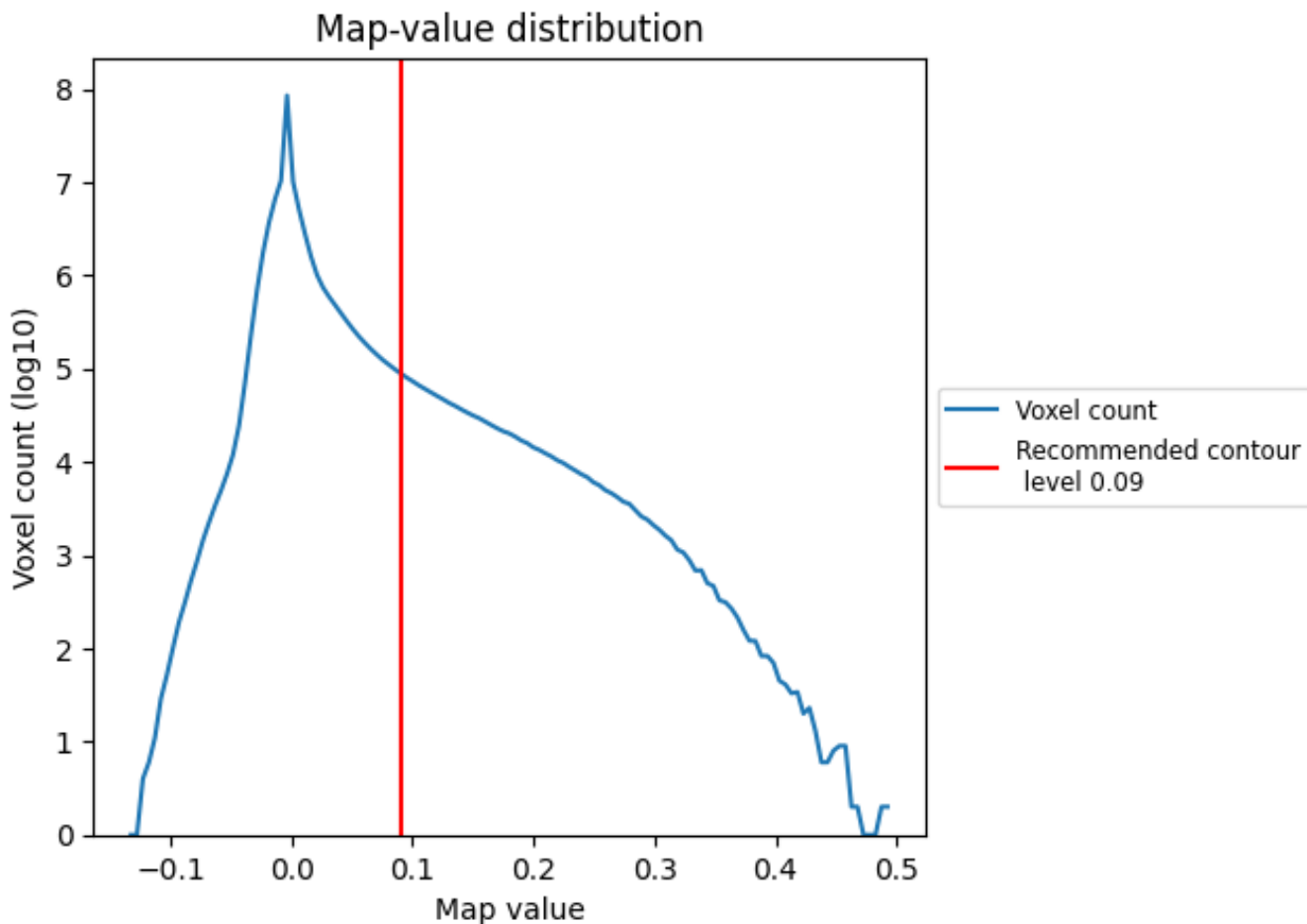

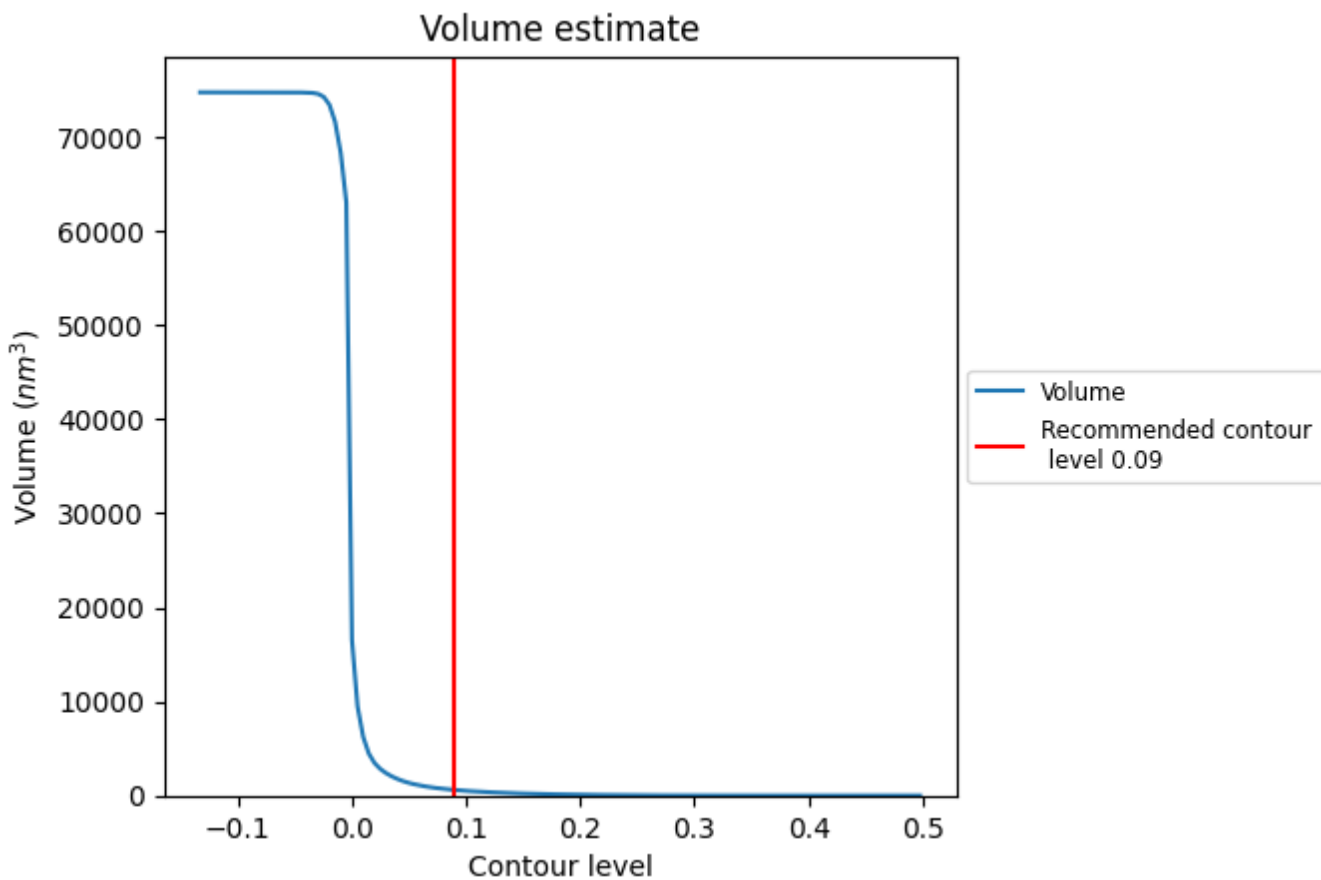

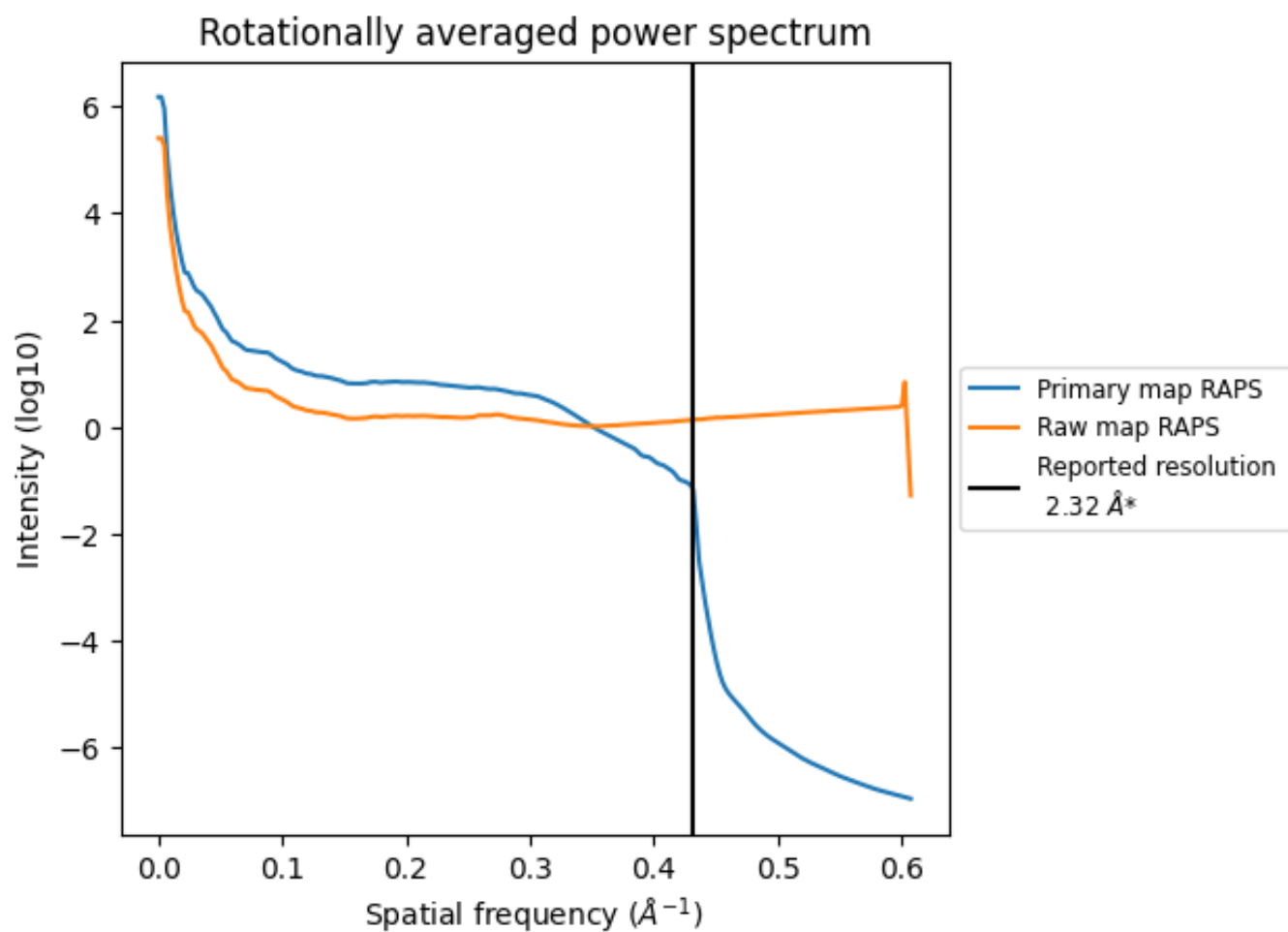
## 7.2 Volume estimate [i](#)

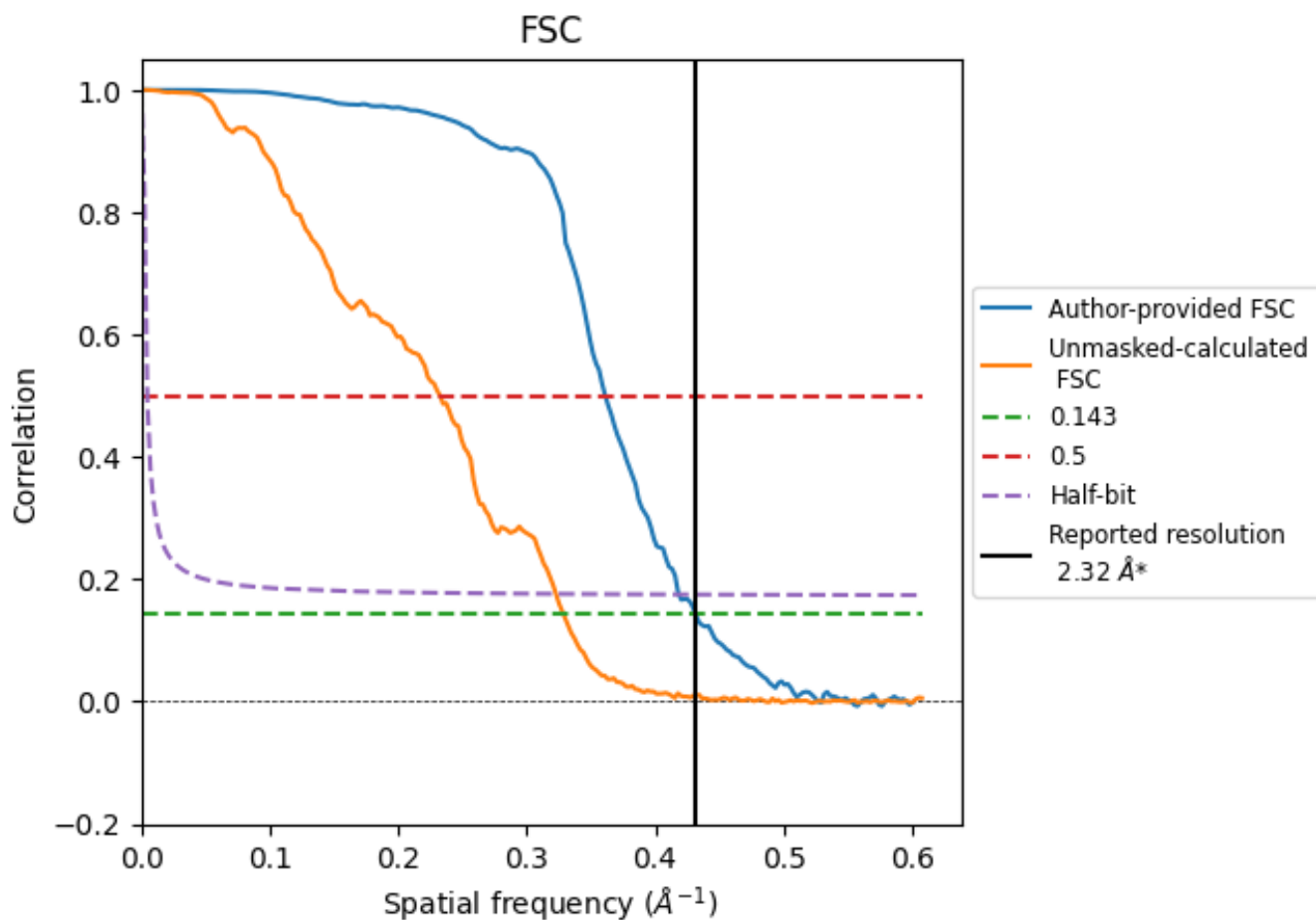

## 8 Fourier-Shell correlation [\(i\)](#)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. The shape of the curve depends on the imposed symmetry, mask and whether or not the two 3D reconstructions used were processed from a common reference. The reported resolution is shown as a black line. A curve is displayed for the half-bit criterion in addition to lines showing the 0.143 gold standard cut-off and 0.5 cut-off.

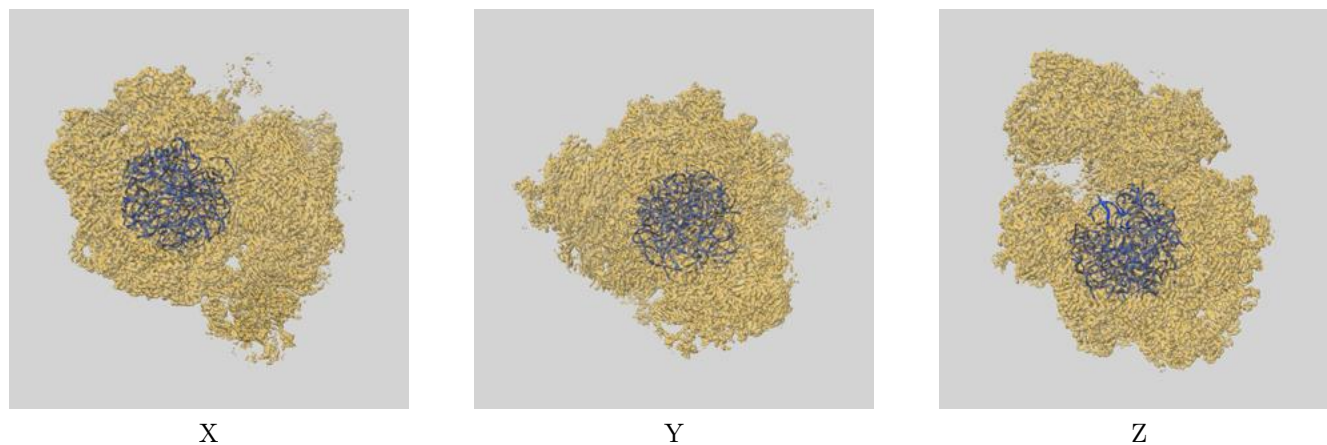

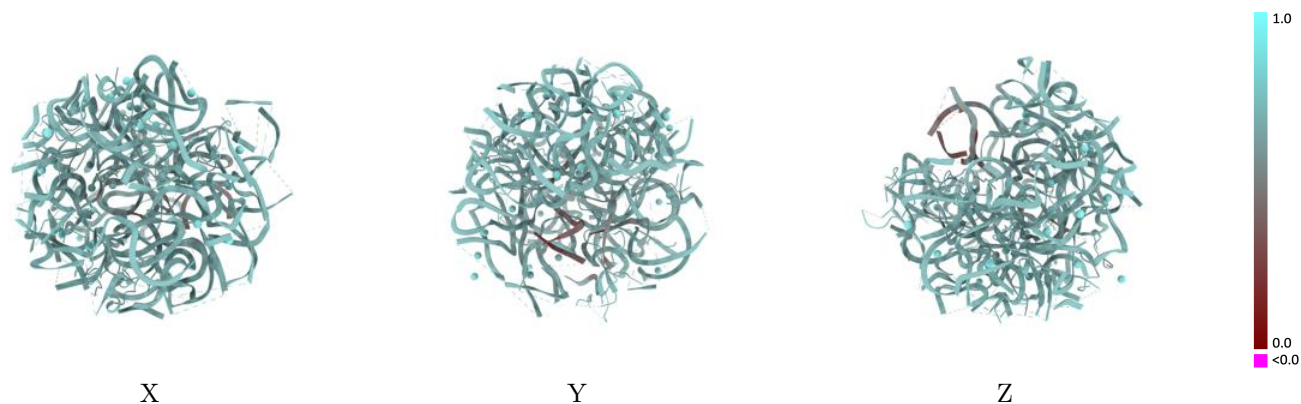

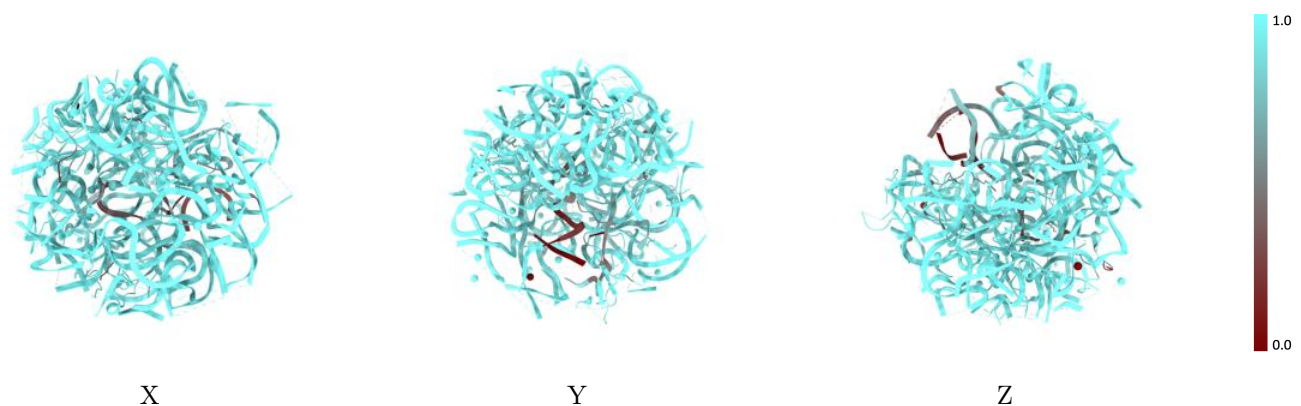

## 9.2 Q-score mapped to coordinate model [\(i\)](#)



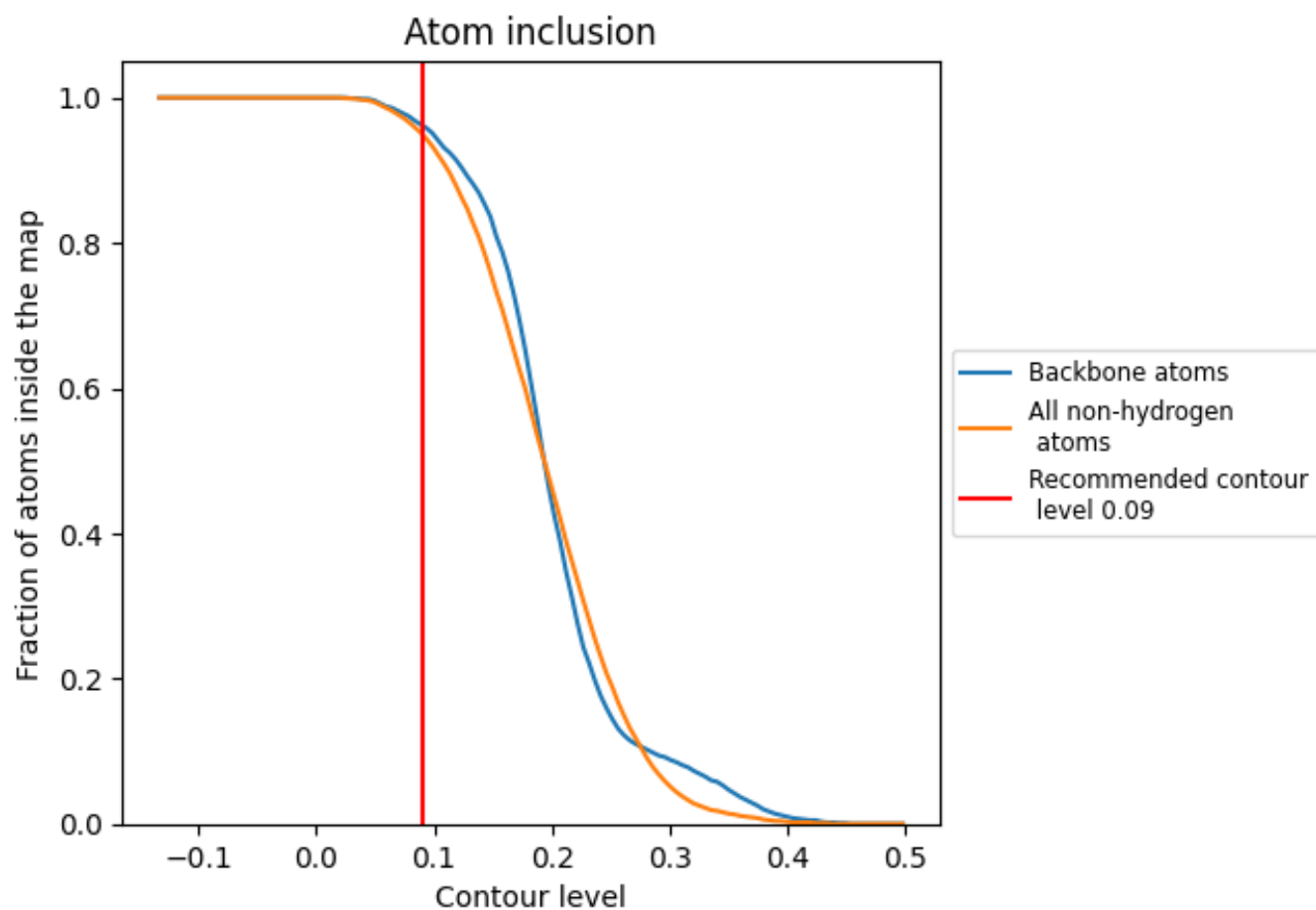

The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.09).































